**AKL** and **MU** shall hereinafter be individually referred to as **Party** and collectively referred to as **Parties**.


### WHEREAS:

- A. **AKL** is engaged in the business of Aviation / Aerospace Education including but not limited to Flight Training, Cabin Crew Training, Aircraft Maintenance Engineering Training, Remote Pilot Training for UAVs, Research & Development of Technologies, Technical Consultation.
- B. **MU** is an Autonomous body set up by the Government of Rajasthan through Act. No. 4 of 2009 passed by the Rajasthan Legislative Assembly (Government of Rajasthan). The University is recognized by the UGC u/s 12(f) of UGC Act with powers to confer degrees u/s 22(1) of the UGC Act, 1956
- C. The Parties acknowledge the importance of using their respective efforts, necessary support, guidance, network, and resources to ensure the success of the cooperation.
- D. The Parties acknowledge that, having shared interests and common objectives, this cooperation will contribute to the further growth of both the Organizations in their respective spheres of influences.
- E. The Parties have expressed their willingness to collaborate as part of implementing common interests and intentions including but not limited to the terms and conditions established in this Agreement, with the purpose of carrying out activities, which are of mutually beneficial interest.

**NOW, THEREFORE**, in consideration of the mutual covenants and agreements set forth in this Agreement, and for other good and valuable consideration, the sufficiency of which is acknowledged by the Parties, do hereby agree as follows:

## **1. SUBJECT OF THE AGREEMENT**

- 1.1. AKL and MU express their mutual interest to cooperate in the areas including but not limited to  
a) Aviation Cabin Crew Training b) Aircraft Maintenance Engineering c) Establishment of Infrastructure for Aviation related programs d) Possible Financial Partnerships in such programs e) Aviation / Aerospace Outreach programs – To increase Aviation / Aerospace Awareness in India f) Technical Advisory in Aviation, Engineering, Research & Technology related avenues.
- 1.2. The Parties acknowledge the importance of using their respective efforts, necessary support, guidance, network, and resources to ensure the success of cooperation.
- 1.3. The Parties have expressed their willingness to collaborate as part of implementing common interests and intentions including but not limited to the terms and conditions established in this MoU, with the purpose of carrying out activities, which are of mutually beneficial interest.
- 1.4. The formalization of the specific steps in relation to the administrative, legal, financial, and organizational aspects of implementing projects, on a case-by-case basis, will be determined according to the procedures within the internal Regulations of the Parties and as per mutual agreement either through written or verbal consent of the said parties.
- 1.5. MU under this Agreement appoints AKL as the Technical Advisor for its Aviation, Engineering & Technological directions. MU also provides AKL with the mandate of being the sole & exclusive Technical Advisory for the abovementioned directions under this MoU.

## **2. REPRESENTATION**

- 2.1. AKL appoints Mr. Vaibhav Varun, Managing Director as the person in charge of this MoU and for the relations with the Party. In the event of any replacement of the person in charge, AKL will notify Party in written form immediately.
- 2.2. MU appoints Mr. Harish Gurnani, Director as the person in charge of this Agreement and for the relations with the Party. In the event of any replacement of the person in charge, MU will notify Party in written form immediately.
- 2.3. Unless otherwise provided herein, all notices or otherwise communicated under or in connection with this MoU shall be given in writing and may be sent by personal delivery or post or any

### 3. CONFIDENTIALITY

3.1. Any Confidential Information received by either party hereto pursuant to this MoU shall be used, disclosed, or copied, only for the purpose of, and only in accordance with this Agreement.

3.2. The receiving party shall use, as a minimum, the same degree of care as it uses to protect its own Confidential Information of a similar nature or publication of confidential information. Without prejudice to the generality of the foregoing:

3.2.1. The receiving party shall only disclose Confidential Information to its bona fide employees, contractors or supplies who need to obtain access thereto for purposes consistent with this Agreement as well as the subsequent agreements in which the collaboration between the Parties will be established.

3.2.2. The receiving party shall not make or have made any copies of Confidential Information except those copies which are necessary for the purpose of this Agreement and

3.2.3. The receiving party shall affix to any copies it makes of the Confidential Information, all proprietary notice or legends affixed to the Confidential Information originally received from the disclosing party.

3.3. Except for disclosures authorized under the terms of this Agreement, the receiving party shall notify the disclosing party immediately upon learning of any disclosure of the disclosing party's Confidential Information.

3.4. During the tenure of This MoU and for 3 (three) years after the successful completion of this MoU / termination of MoU, Parties herein undertake on its behalf and on behalf of its employees / representatives / associates involved in the project to maintain a strict confidentiality and refrain from disclosure thereof, of all or any part of the information and data exchanged / generated from the project under this Agreement for any purpose other than in accordance with this Agreement.

3.5. The parties shall not have any obligation of confidentiality with respect to any information that:

3.5.1. Is in the public domain by use and / or publication at the time of its receipt from the disclosing party; or

3.5.2. Was already in its possession prior to receipt from the disclosing party; or

3.5.3. Is properly obtained by the recipient from the third party with a valid right to disclose such information and such third party is not under confidentiality obligation to the disclosing party;

3.5.4. Is required by public authority by law or decree.

3.6. Any and all information received by either party from the other upon request shall be promptly returned, however, the parties involved in the project may retain one copy of such information in their confidential files, solely for record purposes.

#### 4. TENURE & TERMINATION

4.1. This Agreement shall be effective from the date of signing (Effective Date) and be valid for a period 3 (three) years thereafter.

4.2. During the tenure of the Agreement, parties hereto can terminate their part of this Agreement either for breach of any of the terms and conditions of this Agreement or otherwise whatever may be the reason for termination by giving a two months' notice in writing.

4.3. The termination communique shall be sent in writing either through Registered mail with acknowledgement of receipt or by certified e-mail.

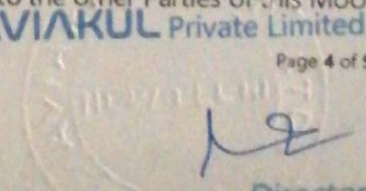
#### 5. GOVERNING LAW, JURISDICTION AND ARBITRATION

5.1. This MoU shall be interpreted in accordance with and governed by the laws of India without regard to any conflict of laws principles. All disputes arising out of or in connection with this Agreement shall be subject to the sole and exclusive jurisdiction of the courts of New Delhi.

5.2. All disputes and differences arising out of or in connection with or touching upon this MoU shall be amicably settled by mutual discussion between the authorized representatives of the Parties within a period of 30 days of the disputing Party giving notice to the other Parties of this MoU.

5.3. In the event the dispute is not resolved by the authorized representatives within the aforesaid period, the Parties to dispute shall refer disputes and differences for final resolution through arbitration.

5.4. The venue of Arbitration proceedings shall be the location of the defendant and the language used in arbitration proceedings shall be English.

5.5. The costs of the arbitration shall be borne by the disputing Parties in such manner as the arbitrators shall direct in their arbitral award.

## 6. ENTIRE AGREEMENT, MODIFICATION & COUNTERPARTS






**Mewar University** having its office at NH - 79 Gangrar, Chittorgarh, Rajasthan-312901, India and represented through its Chairman Dr. Ashok Kumar Gadiya (herein referred to as "MU") which expression, shall unless it be repugnant to the subject of the context thereof, includes its successors and assigns;

"BFIN" and "MU" are hereinafter referred individually as "**Party**" and collectively as "**Parties**".

### 1. Description of Both Institutions:

1.1. **Banking, Finance and Insurance Institute of Nepal (BFIN)** is established under Company Act 2063 on August 14, 2018. BFIN is promoted by 16 national level institutions of Nepal represented by commercial banks, development banks, finance companies, micro credit institutions, capital market institutions and the Emerging Nepal Limited. The main objectives of BFIN are to offer training, workshop and seminar and enhance the knowledge, skills and capabilities of the employees of financial sector and other stakeholders, conduct research and consulting to strengthen the financial sector, offer specific accredited courses and creating data bank for the use of banking community and help to strengthen the financial systems in Nepal.

1.2. **Mewar University (MU)** is promoted by the Mewar Education Society (MES). It is controlled by a Board of Management, constituted by the MES, which is headed by Chairperson Shri Ashok Kumar Gadiya, a great visionary, educationist, and nationalist, who translated his ideas and dreams of promoting higher education into reality by setting up institutes of learning in various subjects. In no time, he has carved out a niche for himself as an educationist, who believes in inculcation of values through education in the young generation.

### **Memorandum of Understanding (MoU)**

The purpose of this Memorandum of Understanding (MoU) is to underpin the development of a long-term partnership between BFIN and MU for conducting and coordinating in the areas of training, education, research and consultancy Services, Information Technology and other allied services offered by both Institutions.

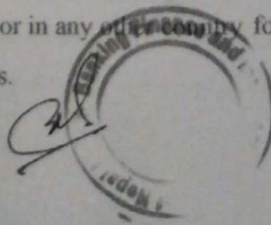

It therefore, sets out matters of agreed principles and policies, reflecting the spirit of co-operation between BFIN and MU as hereunder:

#### **2. Aims and Objectives of the Joint Activity:**

- 3.1. Both the institutions agree to collaborate in various areas like organizing joint workshops, training programs, exposure visits, study tours, seminars and conferences on various emerging topics and to offer / organize any other program/activity/event mutually agreeable to both the Parties.
- 3.2 **BFIN and MU**, in future, if need arises, and subject to various regulatory/statutory and other clearances, will explore/examine and mutually agree through a separate MOU for providing professional accredited short term and long term diploma/degree courses in the areas of cooperative management, technology, banking, finance, management, and its modality of operation, examination, cost structure and on completion of the course, for receiving certification from MU.
- 3.3 Both Institutions agree to enhance staff and Executive development opportunities by fully exploiting the strengths of both institutions, to the benefit of all concerned.

#### **3. Agreement between BFIN and MU**

- 3.1. The Parties agree to collaborate in various areas like organizing joint workshops, training programs, seminars and conferences on various emerging topics and to offer / organize any other program/activity/event within the competence of both the Institutions, whenever any such need/requirement is proposed either by BFIN or by MU.
- 3.2. Both the Parties may offer their office infrastructures and facilities, subject to availability, at mutually agreed minimum cost basis or free of cost as appropriate, to each other or arrange the same for conducting events, programs, training, etc.
- 3.3. Both the parties in collaboration shall explore to hold some training, conferences, exposure visit, etc., in Nepal and/or India or in any other country for enhancing the knowledge and skills of officials of both countries.

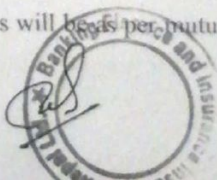





- 3.4. Both the Parties agree to promote the common programs on their respective websites & other social media platforms, as and when required.
- 3.5. Both the parties agrees to acknowledge as "Preferred Partner" in domain of expertise offered by both the institutions and support each other.
- 3.6. Both the parties agree to use their Logo and strategic alliance related information at their websites and in other formal publications.
- 3.7. Both the parties agree to support each other with the exchange of faculties or resource persons, while hosting conference, training and webinars. The faculty can be drawn from MU and BFIN, government, CEOs and senior level officials from BFIs, academicians in respective fields, available within and outside of both the countries.
- 3.8. Both the parties agree to find out scholarship/ grant/fund, as appropriate, for hosting the joint programs. The terms and conditions for hosting joint programs shall be decided project-wise.
- 3.9. Both the parties agree to provide access to their respective network and alliances for mutual benefits and strengthening relationships.
- 3.10. While hosting a customized program, general program, conference and seminar and the certified long-term diploma and degree courses in Nepal; the fees will be decided at the time of finalization of each program separately after mutual discussion with representatives of BFIN and MU.
- 3.11. Both the parties agree to support each other with course outlines, reading materials, case studies, books and journals; and other relevant information such as online library as applicable; for the use of other and enhance the knowledge base of both the institutions.
- 3.12. Both the parties agree to circulate information to their member institutions, such as request for writing research article for BFIN's Annual Journal of Banking Finance and Insurance published every year to celebrate the anniversary; and also the request for advertisement for publication in the journal; and
- 3.13. Any other work that may arise for the benefits of both the institutions.

#### **4. Sponsored Research and Consulting Services**

Under this arrangement, both BFIN and MU agree for exploring to collaborate in Research and Consulting activities in the areas of mutual interest and benefit. Such sponsored research will be fostered through the interactions with faculty members of MU and senior executives of BFIN to arrive at research problems. The financials and other terms and conditions of the research and consulting assignments will be as per mutual agreement, which will depend upon





the duration of the project expertise required, research inputs and other incidental expenses.

## 5. Case Studies

Case studies are an important component of executive and organizational development and training. BFIN and MU would explore/attempt to jointly identify various areas where the faculty associated with BFIN and MU will document the situations, or success story/challenges faced through writing the case studies. The case studies developed can also be used by both the organizations for its internal training programs. Both the institutions may publish the case studies in appropriate leading journals after obtaining consent from each other as well as from leading case clearing houses, thereby enhancing the brand visibility of both the institutions.

## 6. Administration:

- 6.1. The authorized signatories / designated representatives of both the Parties shall take requisite actions under this MoU. The designated representatives of the Parties would be responsible for developing and carrying out joint plans and regular reports on the implementation of this MoU.
- 6.2. For the purpose of smooth implementation of the terms of MoU, the Parties agree to mutually decide upon the operational aspects / procedure, including, roles & responsibilities of each Party, financial aspects and such other terms & conditions for each program.
- 6.3. It is agreed that for the purpose of facilitating / implementation terms of this MOU, both the Parties agree to have regular communication and correspondence.
- 6.4. Each Party shall appoint a Coordinator in their respective offices who shall be responsible for coordinating all communication. A coordinator will be appointed for each program/event/activity separately, who in turn will internally coordinate within their respective institutions with regard to working out of the operational and financial aspects. All the operational and financial aspects will be operationalized after acceptance of all the terms by both the Parties by exchange of letters.
- 6.5. The Parties hereby represent and warrant as of the date hereof, that both the institutions are duly incorporated with valid licenses, have power to execute functions mentioned in this MOU, have skills and knowledge to abide this MOU, to perform the functions; and agree that the execution of this MOU shall not violate the provisions of law and order, and the Article of Association and other legal provisions of both the countries.
- 6.6. Both the parties agree that in a process to delivery of services as per this MOU shall not harm the other party, nor make any claim to any right or asset or property, whatsoever, and agree that this MOU is purely to develop professional relations between both the institutions and spread the knowledge base in the region.

## 7. Amendment

Any amendment / alteration to this MOU shall be decided mutually between the Parties hereto and



shall be by way of an addendum to the MOU.

**8. Validity and Termination**





9.1 The MOU shall become effective on the date of this document is executed by the authorized officials of both the Parties and shall remain in force for a **period of five years**. Upon the completion of this term, the MOU may be renewed for a further period of three years or a mutually agreed period upon the assent of both the Parties by execution of addendum.

9.2 Either party may terminate this MOU by written notification signed by the authorized official of that Party. However, the other Party must receive such notification at least 30 days in advance. The termination of this MOU shall not affect the rights and obligations of the Parties prior to such termination. It is clarified that if any course / event / activity has already been initiated then the termination, if any, shall be effective only after completion of the course for that year and before the commencement of the next course.

**9. Undertaking by BFIN and MU**

The Parties hereby undertake to work closely and cooperate in the implementation of this MOU and to endeavor to resolve disputes arising between them in relation to this MOU by amicable means. In the event that the Parties are unable to resolve any dispute by amicable means, then this MOU may be terminated by mutual consent of both the parties subject to completion of ongoing events / programs.

## BACKGROUND

The University is also NAAC accredited and conflict and impart various certificate/diploma/Advance Diploma/Degree/Doctorate/ Industrial and Vocational Training and Education in India By Ways of Various Course.

### **2. International Institute of Risk & Safety Management (IIRSM)**

We do this through setting standards, connecting people and organisations, and providing practical education, training, advice and resources.

### **Article 1: Objectives**

The purpose of this MOU is to define the terms and conditions for cooperation and collaboration between **MEWAR UNIVERSITY, CHITTORGARH** and **INTERNATIONAL INSTITUTE OF RISK & SAFETY MANAGEMENT (IIRSM)** in areas relevant to Risk and Safety Management .

### **Article 2: Areas of Cooperation**

**Suggested areas of cooperation between the center and the institution:**

1. To exchange the best and latest practices in areas related to risk management, safety and health and accident prevention.
2. Cooperation in various activities related to occupational Risk and Safety through continuous education and training, through:
  - Capacity building, training, professional development, and obtaining scientific and professional qualifications.
  - Encouraging practitioners to follow best practices in the field of Risk and Safety.
  - Promote collaboratively the culture of Risk and Safety management in the Communities.



3. Promote the concept of risk, safety and health through awareness programs, and participating in seminars, workshops and conferences..
4. Creating a common electronic database on Risk and Safety management related topics.
5. Cooperation in implementing projects related to improving the concept of Risk and Safety.
6. Cooperation in the research, information and technical support in the field of Risk and Safety.

### **Article 3: Expenditure**

1. Unless agreed otherwise, each party shall bear its own expenses incurred from implementing its roles under this MOU.
2. Proposals / projects requiring special funds / budgets for implementation shall be subject for further processing as required by the two parties.

### **Article 4: Mechanisms for Coordination**

1. This MOU is non-legally binding, but serves as a definite expression and record of the purpose and intention of the Parties concerned to carry out the roles specified in this MOU with mutual loyalty and friendly cooperation.
2. Neither Party shall by virtue of this MOU deem to be in a relationship of partnership, agency or employment with the other.
3. Neither party shall act on behalf of the other Party or represent the other Party or bind the other Party or be responsible for the other Party in any way.
4. In order to coordinate and implement all activities related to this MOU, a technical coordinator from each party will be nominated.
5. Should any dispute arise over this MOU, the Parties will make every effort to amicably resolve the matter in good faith through cooperation, consultation and dialogue.
6. The parties may by mutual agreement develop separate "project agreements" to detail their involvement in specific areas, by designated representatives from each party under relevant terms and financial agreements, which, upon agreement by the parties, will be considered as supplements to this MoU.

### **Article 5: Entry into force, termination, modification**

1. The timeframe for this MOU is 3 years and shall come into effect on the date of the signature of the authorized representatives of the two Parties.
2. The Parties may decide to renew the MOU on such terms and conditions as they may agree.
3. Either Party may terminate the MOU by giving not less than 2 months' written notification to the other Party. Such termination shall be without any legal consequences on any party except as noted in the next point.



4. All projects which were commenced before the date of the written notice, and which have not been completed as at the date of the written notification, will continue until they are completed, unless the Parties agree not to.

#### **Article 6: Confidentiality**

1. Each Party shall not release any confidential information acquired from the other Party in the course of carrying out its responsibilities under this MOU to any third party without the other Party's prior written consent. The recipient Party shall take all reasonable precautions to prevent unauthorized access by any person to confidential information provided by the other Party.
2. For the sake of clarity, all documents marked with CONFIDENTIAL will be deemed as confidential information.
3. The obligation of confidentiality created pursuant to this article shall expire with the expiry or termination of this MOU except for information already disclosed and expressly identified by its disclosing party, at the time of expiry / termination of the MOU, as requiring continued treatment as confidential information for a further specific period, which is not to exceed 2 year beyond the expiry / termination date of the MOU.

#### **Article 7: Intellectual Property**

This MOU does not mandate the transfer of intellectual property rights between the Parties. All such rights shall remain vested solely in the providing Party. Any transfer of intellectual property rights, if any, shall occur only when a separate MOU is executed between the Parties.





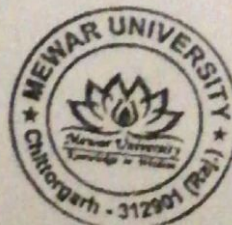
In accordance with the mutual consent to promote cooperation between the Indian Institute of Sugarcane Research, Lucknow and Mewar University, Gangrar, Chittorgarh (Rajasthan), both the University and the Institute enter in to a formal statement of collaboration in the form of Memorandum of Understanding (MOU) for the purpose of academic interaction.

**Mewar University** is having its main campus at NH- 79 Gangrar, Chittorgarh (Rajasthan) and camp office at Sector 4C, Vasundhara (Ghaziabad). Mewar University is an autonomous body promulgated by the Government of Rajasthan through Act No. 4 of 2009 and passed the Rajasthan Assembly. The University is further approved by the UGC under u/s 2(f) of the UGC Act 1956.

This Memorandum of Understanding entered into on 14<sup>th</sup> December, 2012 between the Mewar University, an Institution, imparting and offering educational courses hereinafter referred to as ("Mewar University") –located at Gangrar, Chittorgarh, Rajasthan and represented by CA Ashok Kumar Gadiya, Chairperson of the University, which expression shall unless repugnant to the context means and include its successors and assigns of the ONE PART. Wherever the word University comes in this MOU, it implies Mewar University.

**Indian Institute of Sugarcane Research (IISR)**, Lucknow is having its office at Indian Institute of Sugarcane Research, Raibareli Road, P.O. Dilkusha, Lucknow - 226 002.







IISR, Lucknow was established in 1952 by the erstwhile Indian Central Sugarcane Committee for conducting research on fundamental and applied aspects of sugarcane culture as well as to coordinate the research work done on this crop in different states of the country. The Government of India took over the Institute from the Indian Central Sugarcane Committee on 1st January, 1954. It was transferred to the Indian Council of Agricultural Research (ICAR), New Delhi on April 1, 1969. The Institute is located in Lucknow, the capital city of Uttar Pradesh and conveniently situated at about 12 kms from CCS Amausi Airport and about 5 kms each from Lucknow Railway Station and Alambagh Bus Station. The mandate of the Institute approved by the ICAR is as follows:

1. To conduct basic and applied research on all aspects of production and protection techniques of sugarcane and other sugar crops particularly sugar beet for different agro climatic zones of the country.
2. To work on the breeding of varieties for subtropical region in close collaboration with Sugarcane Breeding Institute, Coimbatore.
3. To carry out research for diversification and value addition in sugarcane.
4. To develop linkages with State Agricultural Universities, Research Centres and other organizations for collaborative research, exchange of information and material, and
5. To provide training, and consultancy to end users at regional, national and international levels.

IISR is represented herein by Dr Sushil Solomon, Director (hereinafter referred to as "IISR" which expression shall unless repugnant to the context means and include its successors and assigns of the OTHER PART.

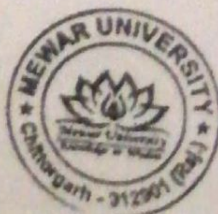
#### WHEREAS

The University and IISR Lucknow have decided to collaborate for various academic activities.

#### 1. RESPONSIBILITIES OF THE IISR

The IISR (Indian Institute of Sugarcane Research, Lucknow) will facilitate the following:

- (i) B. Sc. (Ag), B. Sc. (Home Science), B Tech., M.Sc. (Ag), M Tech. and Ph.D students registering with the University will be allowed to carry out their research project pertaining to sugarcane and other sugar crops at IISR, Lucknow as per the requirements and approved plan of work.
- (ii) Periodic training (summer or winter) as required for fulfillment of course work under different programmes of the University at nominal charges by the Institute from time to time.





- (iii) Periodical meetings of the students supervisors either at the premises of ICAR Institute or University.

## 2. RESPONSIBILITIES OF THE MEWAR UNIVERSITY

Mewar University will facilitate the following:

- (i) The University shall recognize the ICAR Institute (IISR, Lucknow) and specific disciplines/divisions /departments as Centres for conducting research work for the award of post graduate/ Doctoral degrees.
- (ii) The scientists/ officers of the Institute on their individual merit and in accordance with the University rules and regulations shall be recognized as Co- guide for guiding research.
- (iii) University may invite IISR scientists/ experts to deliver guest lectures as per requirement in various courses. However, TA and DA will be provided by the concerned University. Suitable honorarium may also be given to concerned scientist as per University rules.

## 3. GENERAL

- a. Benefits such as improved technology, material, machinery, process, designs and techniques, accruing or arising from this effort may be used by either or both the parties with due recognition of each party's contribution.
- b. Results from collaborative research may be used by either or both the parties with due recognition of each party's contribution.
- c. Research findings as a result of this collaborative work of both the parties will be published in the public interest.
- d. Research findings published by either party will give due credit to others party's contribution, but the publishing party shall be entirely responsible for conclusions and interpretations reported.
- e. During the study period at both the Institutes, the head of the University/ Institute will be the Controlling authority and candidate shall be bound to get permission to leave the place of work from the Controlling authority.

## 4. VALIDITY OF MOU

This agreement will be in effect initially for a period of ten years from the date of signing this MOU by both the parties and renewed further if mutually agreed.

Either party may terminate the agreement by written notification signed by the appropriate official of the institution initiating the notice. Such notice must be received by the other party six months prior to the effective termination date.





However, obligations and commitments already contracted shall be honored and continued by both the parties until such commitments are cover.

## PARTIES to this MOU

This Memorandum of Understanding (MOU) is entered on 15<sup>th</sup> February 2022 in English by and between **MEWAR UNIVERSITY, CHITTORGARH, RAJASTHAN AND INTERNATIONAL INSTITUTE OF RISK & SAFETY MANAGEMENT (IIRSM)**

## BACKGROUND

### **1. Mewar University, Rajasthan**

MEWAR UNIVERSITY is an autonomous body set up by the Government of Rajasthan through Act. No. 4 of 2009 passed by the Rajasthan Legislative Assembly (Government of Rajasthan). The University is recognized by the UGC u/s 2(f) of UGC Act with powers to confer degrees u/s 22(1) of the UGC Act, 1956 vide their letter no. F.9-15/2009(CPP-I) dated 30<sup>th</sup> March, 2009. This is the only private and self-financed University in Rajasthan which is also approved by the UGC u/s 12B of the UGC Act vide their letter No. F.9-15/2009 (CPP-I/PU). The University is also NAAC accredited and conflict and impart various certificate/diploma/Advance Diploma/Degree/Doctorate/ Industrial and Vocational Training and Education in India By Ways of Various Course.

### **2. International Institute of Risk & Safety Management (IIRSM)**

IIRSM is a professional body for those responsible for managing risks in all their forms. IIRSM champions risk management to drive positive change for both employee and organisational wellbeing. We do this through setting standards, connecting people and organisations, and providing practical education, training, advice and resources.

### **Article 1: Objectives**

The purpose of this MOU is to define the terms and conditions for cooperation and collaboration between **MEWAR UNIVERSITY, CHITTORGARH** and **INTERNATIONAL INSTITUTE OF RISK & SAFETY MANAGEMENT (IIRSM)** in areas relevant to Risk and Safety Management .

### **Article 2: Areas of Cooperation**

#### **Suggested areas of cooperation between the center and the institution:**

1. To exchange the best and latest practices in areas related to risk management, safety and health and accident prevention.
2. Cooperation in various activities related to occupational Risk and Safety through continuous education and training, through:
  - Capacity building, training, professional development, and obtaining scientific and professional qualifications.
  - Encouraging practitioners to follow best practices in the field of Risk and Safety.
  - Promote collaboratively the culture of Risk and Safety management in the Communities.



3. Promote the concept of risk, safety and health through awareness programs, and participating in seminars, workshops and conferences..
4. Creating a common electronic database on Risk and Safety management related topics.
5. Cooperation in implementing projects related to improving the concept of Risk and Safety.
6. Cooperation in the research, information and technical support in the field of Risk and Safety.

### **Article 3: Expenditure**

1. Unless agreed otherwise, each party shall bear its own expenses incurred from implementing its roles under this MOU.
2. Proposals / projects requiring special funds / budgets for implementation shall be subject for further processing as required by the two parties.

### **Article 4: Mechanisms for Coordination**

1. This MOU is non-legally binding, but serves as a definite expression and record of the purpose and intention of the Parties concerned to carry out the roles specified in this MOU with mutual loyalty and friendly cooperation.
2. Neither Party shall by virtue of this MOU deem to be in a relationship of partnership, agency or employment with the other.
3. Neither party shall act on behalf of the other Party or represent the other Party or bind the other Party or be responsible for the other Party in any way.
4. In order to coordinate and implement all activities related to this MOU, a technical coordinator from each party will be nominated.
5. Should any dispute arise over this MOU, the Parties will make every effort to amicably resolve the matter in good faith through cooperation, consultation and dialogue.
6. The parties may by mutual agreement develop separate "project agreements" to detail their involvement in specific areas, by designated representatives from each party under relevant terms and financial agreements, which, upon agreement by the parties, will be considered as supplements to this MoU.

### **Article 5: Entry into force, termination, modification**

1. The timeframe for this MOU is 3 years and shall come into effect on the date of the signature of the authorized representatives of the two Parties.
2. The Parties may decide to renew the MOU on such terms and conditions as they may agree.
3. Either Party may terminate the MOU by giving not less than 2 months' written notification to the other Party. Such termination shall be without any legal consequences on any party except as noted in the next point.



4. All projects which were commenced before the date of the written notice, and which have not been completed as at the date of the written notification, will continue until they are completed, unless the Parties agree not to.

#### **Article 6: Confidentiality**

1. Each Party shall not release any confidential information acquired from the other Party in the course of carrying out its responsibilities under this MOU to any third party without the other Party's prior written consent. The recipient Party shall take all reasonable precautions to prevent unauthorized access by any person to confidential information provided by the other Party.
2. For the sake of clarity, all documents marked with CONFIDENTIAL will be deemed as confidential information.
3. The obligation of confidentiality created pursuant to this article shall expire with the expiry or termination of this MOU except for information already disclosed and expressly identified by its disclosing party, at the time of expiry / termination of the MOU, as requiring continued treatment as confidential information for a further specific period, which is not to exceed 2 year beyond the expiry / termination date of the MOU.

#### **Article 7: Intellectual Property**

This MOU does not mandate the transfer of intellectual property rights between the Parties. All such rights shall remain vested solely in the providing Party. Any transfer of intellectual property rights, if any, shall occur only when a separate MOU is executed between the Parties.

#### **Article 8: Contacts**

The senior management contacts for this MOU will be its signatories.

The primary contacts of both Parties for this MOU are the technical coordinators and will be as follows:

Mewar University, Chittorgarh and Wavemakers hereby agree to the same in accordance with the terms of this Agreement.


**NOW, THEREFORE, THE PARTIES HEREBY AGREE AS FOLLOWS:**

1. **Definitions**

The terms defined here under shall have the meaning attributed to them for purposes of this Agreement unless expressly stated otherwise or repugnant to the context.

- a. **“Confidential Information”** shall mean any and all information contained in and/or relating directly or indirectly to this Agreement, including but not limited to the terms of this Agreement, information relating to either Party’s business or financial or other affairs. Confidential information also includes any information related to business, financials, products, or other affairs of the start-ups or entrepreneurs incubated under Mewar University, Chittorgarh Incubation Centre. Confidential Information shall not include (i) any information in the public domain, and (ii) information that is already known to a Party, or lawfully obtained by a Party from a third party without breach of any obligation of confidentiality under this Agreement, or breach of this Agreement.
- b. **“Entrepreneur”** shall mean a person who set up a business(s), company(s), organisation(s), partnership(s), LLP(s), or any other legally recognised entity, for the purpose of making a monetary gain or social welfare.
- c. **“Incubatee”** means an entrepreneur, researcher, student, faculty (individually or as a group) who have been selected based on the selection criteria into the Incubation Center and will undergo mentoring and training under the Incubation Center and/or who have entered into an agreement with Mewar University, Chittorgarh and/or the Host Institution to undergo mentoring and training under in the Incubation Center and/or to develop and produce hi-tech and innovative

- d. **“Pitching Session”** shall mean a session, event, conclave, or meeting, where a start-up presents its business plan to an investor or mentor for any monetary or other support.
- e. **“Start-up”** shall have the same meaning as defined by the Department for Promotion of Industry and Internal Trade, at the date of signing this Agreement.
- f. **“EDP course”** shall have the meaning as Entrepreneur Development Course which aims to get the awareness of various milestones that will help you to get the concepts clear and taking the ventures of an Incubatee. Here incubatee will get the awareness of various milestones that will help his/her concepts clear and taking their ventures to next level through planned learnings.


2. **Purpose:** The purpose of this Agreement is for the parties working together to promote start-ups and young businesses through an incubation process which shall include technical support, supervision, management, strategic planning support, mentoring and Capital among others.

### 3. Principles of Respect and Open Dialogue

- a. The Parties shall be respected for the inputs and outputs they offer to the collaboration. Commitment to open, honest, and direct communication was the basis for crafting the collaboration together and is the premise upon which any work will proceed.
- b. The Parties seek to maintain a high degree of trust among the Parties.
- c. The Parties acknowledge that each brings skills that are beneficial to the collaboration and complementary to the skills offered by other parties. The strength of the collaboration is the diverse perspectives offered by each Party. 

### Memorandum of Cooperation

This Memorandum of Cooperation (MOC) is entered upon between Mewar University having their registered office at N.H. 79, Gangrar, Distt. Chittorgarh Rajasthan (312901) , duly represented by Director, Mewar University as the first party, which includes its successor and assigns, and the Construction Industry Development Council, having their registered office at 801, Hemkunt Chambers, 89, Nehru Place, New Delhi, duly represented by Head Academics second party, which includes its successors and assigns.

Whereas the first party is a University, established by an act no. 04 of 2009 passed by Rajasthan Legislative assembly to further the cause of technical education within its jurisdiction, and, the second party is the apex organization, established by the Planning Commission, Government of India and Construction Industry to stream line the functioning of Construction activities in the Nation.

Whereas the first party desires to enhance the Industry Academia interactions and is desirous of introducing modifications in the working dynamics of the academic and R&D activities, to bring in the functioning in consonance with the needs and requirements of the Industry, and to fulfill these obligations, desires to seek cooperation from the Second Party, who is agreeable to this proposition.



Now, this MOC envisages the terms of joint working as follows.

#### Role of First and Second Party

1. The first party shall modify the curricula / syllabi of the Engineering programmes, at Diploma, Degree, and Post Graduate degree to introduce the inputs desired by the Construction Industry, to be articulated by the Second Party.
2. Shall introduce systems for periodic skill set upgradation for the faculty members engaged with the University / Affiliated Colleges, in Consultation with the Second Party.
3. Shall institute Industry supported R & D programmes in consultation with the Second Party.
4. Shall introduce mandatory Internship programmes for the students of engineering programmes at Diploma, Degree and Post Graduate level, which would be designed and offered by the Second Party, as per the needs and requirements of Construction Industry.
5. Second party will organize the short term training & long term internships for the students of the first party, as per the curricula//syllabi of the engineering programs offered by the first party.
6. In consideration to the MOC, there will be some specific waivers in the fees provided by the second party, for the students of the first party. The fee structure shall be decided by the Second Party.
7. The second party will assist & ensure in connecting the trained students with various organizations & companies for job opportunities.

The MOC envisages that there shall be no reciprocal financial obligations on either of the parties and for the Services rendered they shall make their own investments and charge the fees directly from the beneficiaries.





That the performance of this MOC shall be monitored jointly by the Director (T & P) Mewar University Chittorgarh and Director General, Construction Industry Development Council, who shall be empowered to modify, add, and expand the elements of this MOC.

This MOC shall be valid for a period of 5 years from the date of finalization and thereafter extendable subject to mutual agreement.



This **Memorandum of Understanding** (hereinafter referred to as "**MoU**") entered into on this **01<sup>st</sup> day of December 2020** by and between:

**Mewar University** is an NAAC accredited autonomous university set up by the Government of Rajasthan through Act. No. 4 of 2009 passed by the Rajasthan Legislative Assembly (Government of Rajasthan), (hereinafter referred to as "**MEWAR-U**"), located at NH - 79 Gangrar, Chittorgarh, Rajasthan-312901.

**AND**

**CSIR-Central Electronics Engineering Research Institute**, (hereinafter referred to as "**CSIR-CEERI**") established in 1953, is a constituent establishment of the **Council of Scientific and Industrial Research (CSIR), New Delhi**, having its campus and administrative office in Pilani – 333 031, Rajasthan, India. It is devoted to R&D activities in three areas, namely: (1) Advanced Electronic Systems: Image processing and DSP, Internet of Things (IoT), Embedded System Design, Electronic Instrumentation, Industrial Control & Automation, Power Electronics, Robotics, VLSI Design (Digital, Analog, Mixed Signal), etc.; (2) Advanced Semiconductor Electronics: MEMS, Micro-sensors, Opto-electronic Technologies, Photonic Devices and Sub-systems, Nano-electronics, LTCC and Advanced Packaging technologies, etc.; (3) Microwave Tubes: Klystron, Magnetron, Travelling Wave Tubes, Gyrotron, Plasma Tubes, Tera Hertz devices etc. CSIR-CEERI also has Centres at Chennai, Delhi and Jaipur.





Collectively hereinafter referred to as "institutions"

This MoU is based on the principal of reciprocity and expresses the interest of both institutions in exchanging scholars, students, academics information and materials in the belief that the research and educational process at both institutions will be enhanced and that mutual understanding between their respective scholars and students will be increased by the establishment of such exchange programs as per CSIR Guidelines.

1. The institutions agree to encourage the development of the following exchange programs based on their respective academic and educational needs:

- Exchange of scientific staff
- Exchange of students (undergraduate and / or graduate)
- Joint supervision of M.Tech, M.S and Ph.D. students
- Exchange of academic information and materials
- Exchange of periodicals and other publications
- Organization of joint research programs
- Organization of joint conferences
- Organization of other academic exchanges agreeable to both institutions
- Use of laboratory facilities on mutually agreed terms and conditions

Areas to start this collaboration are listed in Annexure 1. Both the institutions can revisit this list after mutual consultation. The above activities shall be undertaken as per CSIR guidelines.

2. The parties recognize that the implementation of any exchange program will depend upon the academic interests and expertise of individual staff members and upon the availability of financial resources. Accordingly, the implementation of each exchange program based on this agreement shall be separately examined and determined by both institutions. The institutions shall enter into separate agreements regarding the individual exchange programs.


3. Faculty/Scientists of either of the institute initiating collaborative work will take care of the usage of their institute resources and conduction of activities as per institute norms. **Mr. GAURAV SHARMA**, HoD, Department of ECE, MEWAR-U shall be the Coordinator of the CSIR-CEERI &MEWAR-U Collaboration and will coordinate with a scientist from CSIR-CEERI for the implementation of this initiative.



4. Each institution will adhere to the intellectual laws of India. Intellectual property developed during the visit of an exchange student/researcher/faculty/staff will be governed by the rules of the host institute unless otherwise specified. The two institutions shall jointly own results of clearly defined collaborative projects and exchange programs. This joint ownership also entitles each party to explore commercialization. However, transfer of jointly developed technology and associated sharing of revenue shall be governed by a separate agreement. This cost of IP filing will be equally shared by both Institutions.

Furthermore, if one institution receives any information from the partner under a clearly defined non-disclosure agreement, necessary and reasonable care will be taken to protect the intellectual property received.

5. This MoU is not intended to be a legally binding document. It is meant to describe the nature and to suggest the guidelines of the cooperation described above. Nothing therefore shall diminish the full autonomy of either institution, nor will any constraints be imposed by either upon the other in carrying out the agreement. Any disputes shall be resolved through mutual discussion between the highest officials of the respective institutions.
6. Any addition, deletion and /or alteration to this MoU may be effected by writing. A document containing the additions, deletions and /or alterations, and signed by all Parties hereto, shall form an annexure to and be deemed to be a part of this MoU.
7. The agreement shall become effective on the day representatives of both institutions affix their signatures and seals, will be in force for a period of 3 years, and is subject to revision or modification by mutual agreement. It is also understood that either institution may terminate the agreement at any time, although it is assumed that such action would only be taken after mutual consultation at least six months in advance in order to avoid any possible inconvenience to the other institution.

WHEREAS Directorate of Extension Education (DEE), established in 1966 is a constituent unit under the than University of Udaipur, which subsequently by Act of state legislative assembly bifurcated and established Maharana Pratap University of Agriculture and Technology, Udaipur jurisdiction. There are 08 KVKs functioning successfully with full sincerity and dedication for the service to the farming community and society as a whole for ultimate development of the region and country with the objectives:-

- Transfer of technology to farmers and farming community and government and non-government agricultural organizations through various extension programmes especially for the rural people of the state of Rajasthan.
- Providing diverse technical services and consultancy in agriculture to optimize resource utilization and for proper harnessing of technologies.
- Developing linkages at national and international level for education, research and extension education.

WHEREAS Mewar University has been established by an Act No. 4 of 2009 passed by the Rajasthan Legislative Assembly. The University has been recognized and approved by the UGC u/s 2 (f) and 12 B of the UGC Act with powers to confer

the only University in Rajasthan which is NAAC accredited and approved u/s 12B of the UGC Act and recognized by AICTE, PCI, BCI, NCTE. The university is also a member of the Association of Indian Universities (AIU). Mewar University will sponsor students RAWE programme to be conducted at MPUAT, Udaipur.

**WHEREBY it is now agreed between Mewar University and DEE as under:**

- MPUAT will conduct 45 days RAWE programme for the students of Mewar University and it will not include 21 days agro-industrial attachment programme (AIA).
- KVK will charge one time RAWE fee of Rs. 5000/- (Five thousand) per student to be deposited in advance by Mewar University, Gangrar.
- The date of start of the programme will be effective from the date of report of students at KVK/KVKs.
- The students have to make their own food, transport and stay arrangements during RAWE programme in respective villages.

- Students shall strictly comply the discipline and guidelines of MPUAT and regularly attend the programme and have to complete the attendance requirement as per University norms.
- KVK/University will not bear to and fro charges while allocation of students at KVK.
- If any student found involved in misbehave/misconduct or unsocial activities with farm family/KVK staff/college or any person, then such students will be immediately removed from KVK jurisdiction area and his/her RAWEE fee and other charges will not be refunded. In case of any legal matter regarding student activity, Mewar University will be solely responsible.
- Safety of students be entrusted to the personnel deputed from the Mewar University, Gangrar during the Course and the University will not be liable for any hardship caused in the matter.
- The MPUAT will not be responsible to any kind of action against the students under RAWEE programme and also not liable for any kind of compensation arise out of any accident etc. during the programme.
- Priority for RAWEE programme will be given to the students of constituent colleges of MPUAT and accordingly the programme will be decided for colleges/institutes other than MPUAT.
- After completion of RAWEE programme, MPUAT will submit the report on performance of students through respective KVKs and the responsibility for rest of the evaluation processes (grade preparation/interview/viva-voce, etc.) of RAWEE students will lie with the Mewar University, Gangrar.
- The programme may be altered / modified as and when it is felt necessary in discussion with both the parties.
- This programme is only for the academic year (2020-21).
- MPUAT/KVK has right to place any student in any of the adopted villages decided by the Incharge of the particular KVK.
- The KVKs will extend their full support in providing the RAWEE training to the concerned students.
- The MoU may be reviewed every year for its continuation by the mutual consent of the parties.
- This MoU shall be terminated with mutual consent of both the parties.
- In case of any unlawful activity on the part of any of the Parties, the other Party may terminate this MoU by giving one month notice.

- Mewar University, Gangrar will submit medical fitness certificate of all the individual students who will join MPUAT for RAWE programme duly certified either by medical jurist or CMHO from medical hospital prior to join this programme.
- MPUAT will not liable to bear any financial liability on the medical expenditure on the students during this programme.
- Student should completely follow the prescribed guideline of COVID-19 issued from State Government failing which student/students will be expelled from this programme for which student/students himself/themselves will be responsible.

Rajasthan and shall be subject to the executive jurisdiction of the courts of Udaipur to entertain any claim, question or any subject arising and of or concerning this MoU.

## AGREEMENT

This Agreement ("Agreement") is made and entered into on this 12<sup>th</sup> day of April 2022 by and between:

1. **MAX HEALTHCARE INSTITUTE LIMITED**, a company incorporated under the Companies Act, 1956 having its registered office at 401, 4th Floor, Man Excellenza, S. V. Road, Vile Parle (West), Mumbai 400018 (hereinafter referred to as the "MHIL", which expressions shall, unless repugnant or contrary to the context or meaning hereof be deemed to mean and include its affiliates, successors and permitted assigns);

and

2. **Mewar University** NH – 79, Gangrar, Chittorgarh, Rajasthan-312901 (hereinafter referred to as "University" which term shall unless contrary to the context mean and include its assignees, executors, legal heirs & successors).

MHIL and Mewar University are hereinafter collectively referred to as the Parties and individually as the Party.

### WHEREAS:

1. MHIL is in the business of providing healthcare and has established an institute 'Max Institute of Medical Excellence' ("Institute") to impart training to various clinical and paramedical staff in various areas of clinical care.
2. The University imparts medical education in various departments such as physiotherapy, MLT, CVT, BSc Dialysis, BSc Respiratory, B pharma, & BSc Cardiac care etc. and is desirous of seeking internship for its students ("Candidates") through the Institute.
3. MHIL, based on the representation and warranties of the University contained hereinafter, has agreed to provide the requisite internship to the Candidates through the Institute at its healthcare facilities mentioned in Schedule I hereto ("Hospital(s)").

NOW THEREFORE, it is mutually understood and agreed by and between the parties hereto as follows:

1. The University shall be responsible for assigning Candidates to the Institute for the internship, as set out in the University's course descriptions and objectives. The University shall notify the Institute one (1) month in advance of the planned schedule of the internship, including the dates and the number of Candidates. The schedule shall be subject to written approval by the Institute.
2. All training during the internship to the Candidates shall be the responsibility of the Hospitals' physicians that are employed by MHIL. The Institute shall confirm the Hospital(s) where the internship can be carried out based upon the availability of infrastructure, teaching facilities and faculties in those Hospitals.
3. The University, with the Institute's approval, shall select Candidates for the internship.
4. The Hospital shall make available appropriate internship, consistent with patient's rights and with the course description and objectives outlined in respective curriculum of the University, enabling the Candidates to meet the objectives of the educational program.





5. The term of this Agreement shall be for a period of one (1) year from the date of its execution and thereafter same may be renewed for further period as per mutual consent of both the parties herein.
6. The Hospital(s) shall evaluate the performance of the assigned Candidates and the Institute shall issue a 'Certificate of Participation' at the end of the internship program.
7. The University will maintain and retain all records and reports of each Candidate's internship and shall make these records available to the Institute upon request.
8. The University and the Institute shall maintain ongoing communication to coordinate the scheduling of the internship. The Institute and the University shall designate a coordinator who shall coordinate and supervise the Candidate(s) while at the Hospital.
9. In case of a Candidate suffering any illness or injury during the internship, the Hospital will provide emergency care to the Candidate at the Candidate's own expense.
10. In the event that care or treatment is required beyond the emergency, the Candidate shall be responsible for arranging such care or treatment and for all associated costs.
11. The University shall require Candidates to conduct themselves in accordance with the Hospital's rules and regulations. Upon request, the Hospital shall make such rules and regulations available to University and the Candidates for review as necessary.
12. The Institute may terminate any Candidate's assignment when a Candidate is unacceptable to the Institute for reasons of health, performance, or for other reasons which, in the Institute's reasonable judgment and to the extent allowed by law, cause the continued presence of such Candidate at any Hospital not to be in the best interest of the Hospital. Any such action will be reported by the respective Hospital to the University orally and in writing.
13. If either Party wishes to terminate this Agreement, written notice will be given to the other Party at least thirty (30) days in advance of such termination. Reasonable efforts will be made to ensure that Candidates enrolled for internship at the Hospital are afforded the opportunity to complete the experience at that Hospital.
14. The Institute and the University will not discriminate against any employee, applicant or Candidate enrolled in their respective programs because of age, handicap, colour, national origin, race, religion or gender, sexual orientation, social or political affiliation
15. **FEE:** In consideration of the Institute providing internship to the Candidates, the Candidates shall pay to the Institute a fee as mentioned in the below table:

10% special discount shall be provided on total internship fee of all mentioned courses.

**Confidential Information.** The term "Confidential Information" as used in this Agreement, shall include all information disclosed by either Party to the other, including but not limited to the following: (i) any and all information relative to hospitals, consulting companies, Hospital staff, Hospital contacts and Directors/Attending's/Residents information involved with planned Transactions communicated, either directly or indirectly by University to the Hospital, (ii) University client list; and (iii) any information relating to business relationships, business plans, financial data, business contacts or other information of the parties, (iv) any and all Information relative to Hospital and University Candidates, hospital relationships and accreditation initiatives divulged in the process of normal business between the parties.

- a. **Nondisclosure of Confidential Information.** Unless otherwise agreed to in writing, from and after the date of this Agreement, neither Party may divulge, sell or use any Confidential Information of the other Party, or allow any Confidential Information to be divulged or used, except as expressly permitted by the other Party.
- b. **Contact or Solicitation of Customers/Accounts.** The parties agree that as long as this agreement is in place, it will not solicit, divert or take away any Candidates or Medical Schools identified in the Confidential Information produced in conjunction with the Transactions.

For purposes of this Agreement, Candidates and visiting members of University faculty are considered part of the respective Hospital's workforce for purposes of access to and disclosure of protected health information. The Candidates and faculty shall respect the confidential nature of all information that they have access to in accordance with the policies and procedures of University and Institute/ Hospital. Any breach or violation of this clause shall be dealt strictly by Institute and as per the applicable law, which may include expulsion of the Candidate(s). Further, the University and the offending Candidate(s) shall, jointly and severally, be liable to indemnify and hold harmless the Institute and its Hospital(s) against all and any liability, cost, charges, fines, damages, court proceedings, orders, judgments (including reasonable attorney's fee) arising out of or in connection with breach of the provisions of this clause.

16. The University and the Institute agree with one another's operational, regulatory, licensure and accreditation requirements including but not limited to related surveys, audits and other reviews.
17. The Hospital agrees to provide Candidates with copies of, or access to, the Hospital's policies and procedures. The University and the Hospital acknowledge that Candidates shall ONLY use patients' personal health information for educational purposes at the Hospital.
18. Any amendments to this Agreement must be in writing and on mutual consent.
19. The Agreement shall be governed by the Laws of India and the competent courts at New Delhi shall have the exclusive jurisdiction to try any disputes out of or in connection to this Agreement.
20. Each Party agrees and undertakes on behalf of itself and its directors, officers, employees, agents, representatives and any other person acting for or on behalf of the foregoing, by whatever name called (a "Party Representative"), and shall ensure that its directors, officers, employees and Party Representatives, comply with each of the covenants laid herein below for the performance of their respective obligations under this Agreement.





- Each Party agrees and undertakes that it is aware of and shall comply with all Anti-Corruption laws.
- Each Party agrees and undertakes that it shall not, directly or indirectly, provide, make, offer, authorize, or accept, any payment, gift, promise, advantage or anything of value, including money, to or for the use or benefit of any Government Official under circumstances where the Party knew or ought to have known that all or a portion of such payment, gift, promise, advantage or thing of value would be offered, given or promised to:
  - (a) any Government Official (i) in order to influence any act or decision of the Government Official in their official capacity; (ii) to induce the Government Official to act or omit to act in violation of lawful duties or contrary to principles of honesty and integrity; (iii) to obtain, retain or direct business for, with or to the Party or any Party Representative; (iv) to secure any improper advantage; or (v) as a facilitation payment;
  - (b) any person, including a Government Official, in order to (i) influence such a person to act in breach of any fiduciary duty, duty of good faith, impartiality or trust; or (ii) to reward such a person for acting in the manner laid down in this sub-clause (i); or
- Each Party agrees and undertakes that it shall not commit any act or omission which causes or could cause the other Party to breach or commit an offence under the Anti-Corruption Laws.
- Each Party agrees and undertakes that it shall maintain complete and accurate books and records in accordance with the Anti-Corruption Laws, shall not disguise or improperly record any payment or transaction that may violate terms laid down hereunder, the Anti-Corruption Laws or under any other applicable law, including but not limited to payments to Government Officials.
- Each Party shall ensure that it maintains a system of internal controls sufficient to provide reasonable assurances that the Party's transactions and any disposition of Party assets are executed consistent with the authorization of management, including but not limited to using commercially reasonable efforts to ensure that all transactions are accurately recorded and reported in its books and records to reflect the activities to which they pertain, such as the purpose of each transaction, with whom it was entered into, for whom it was undertaken, or what was exchanged. Each Party agrees to retain such books and records for a period of 7 (seven) years.
- Each Party agrees and undertakes to maintain adequate written policies and procedures to comply with all applicable international, national, regional, provincial, state, municipal or local laws and regulations that prohibit tax evasion, money laundering or otherwise dealing in the proceeds of crime or the bribery of, or the providing of unlawful gratuities, facilitation payments, or other benefits to, any Government Official or any other person in any manner whatsoever including as set out hereunder, Anti-Corruption Laws or under any applicable law.
- Each Party shall ensure that its Party Representatives comply with the provisions set out in hereunder and under any related applicable law.
- In the event that any Party becomes aware that it or any Party Representative has breached an obligation hereunder or under any applicable law, it will promptly notify the other Parties, subject to the preservation of legal privilege.
- Neither Party or any of its subsidiaries or affiliates nor any of their respective directors, officers, employees, agents or representatives, is a Sanctioned Person.
- Nothing herein shall require any Party to perform any part of this Agreement or take any actions if, by doing so, the Party would not comply with the Anti-Corruption Laws or the provisions set out hereunder. It is clarified that the obligations in this clause shall survive the termination or expiry of this Agreement.
- For the purpose of this Clause, the following terms shall have the meaning set out herein:





- (a) "Anti-Corruption Laws" shall mean (i) (Indian) Prevention of Corruption Act, 1988; (ii) (Indian) Prevention of Money Laundering Act, 2002; and (iii) all applicable international, national, regional, provincial, state, municipal or local laws and regulations that prohibit tax evasion, money laundering or otherwise dealing in the proceeds of crime or the bribery of, or the providing of unlawful gratuities, facilitation payments, or other benefits to, any Government Official or any other person.
- (b) "Government Official" means any (i) official, employee or any person acting in an official capacity for or on behalf of any branch of government, or any agency, ministry, or department of a government (at any level), (ii) director, officer or employee of an entity or instrumentality wholly or partially controlled by a government (for example, a state owned oil company), (iii) officer, employee, official or any person acting in an official capacity for or on behalf of any political party or public international organization, such as the United Nations or the World Bank, (iv) political party candidate, or (v) immediate family member (meaning a spouse, dependent child, sibling, parent, or household member) of any of the foregoing.
- (c) "Sanctioned Person" means a person that is at any time (a) the subject of Sanctions (b) located in or organized under the laws of a country or territory which is the subject of country- or territory-wide Sanctions (including, without limitation, Cuba, Iran, North Korea, Sudan, Syria or the Crimea region); or (c) owned 50% or more, or controlled by, any of the foregoing.




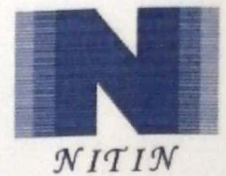

Nitin spinners, located at Bhilwara represented by their General Manager ( hereinafter ) called “Nitin Spinners” which expression shall where the context so admits include its successor and permitted assignees of the second part.





## PREAMBLE

Mewar University is an autonomous body promulgated by the Govt. of Rajasthan through an act passed by the Rajasthan assembly and further approved by the university grants commission, has hosted a large number of national students with representation from 29 states & international students representing countries like Nigeria, Sudan, Ghana, Yemen, Afghanistan, Zimbabwe etc to name a few.

Nitin Spinners, an ISO 9001:2015 Company and a Government of India Recognized Export House, has today emerged as one of India's largest and reputed producers of 100% cotton yarn and fabrics. ## Responsibilities of Mewar University & Nitin Spinners


