Sub.: **Temporary approval of affiliation of Faculty of Law, Mewar University, Gangrar, Chittorgarh, Rajasthan for three year LLB, five year BA. LLB, and BBA.LLB law courses.**

Sir,

Legal Education Committee at its meeting held on 7<sup>th</sup> July, 2012 considered the inspection report of the above mentioned college and Committee made the following recommendations:-

The Legal Education Committee considered the recommendation of the Standing Committee. After consideration, Committee is of the view that as per Section 7 (1) (i) of the Advocates Act, 1961 University be granted recognition for the purpose of conferring the degree of law for imparting three year LLB, five year B.A. LL.B and BBA.LLB courses and temporary approval of affiliation to its Faculty of Law for imparting three year LLB, five year BA.LLB and five year BBA.LLB courses with intake of two sections of 60 students in each section in each course for a period of two years from 2012-2013 to 2013-2014 subject to the following conditions.

1. The college management is directed to establish the Legal Aid Centre as per Clause-11, Schedule-III of Rule-11 of the Part-IV of the Legal Education Rules - 2008.
2. The institution is directed to upgrade the library by investing Rs. 50,000/- per year per stream.
3. Subject to further condition that teaching staff should be paid at least U. G. C. scale by Cheque.
4. Institute should submit affidavit in the compliance to the above conditions within three months.

The above recommendations were considered by the Bar Council of India at its meeting held on 8<sup>th</sup> July, 2012 and accepted the same.


The college shall also comply with the following Rule of the Bar Council of India (Clause (iii) and Explanation 2 of Schedule IV in Part IV of new rules of the Bar Council of India):-

***“Whenever approval of affiliation is granted to the Centres of Legal Education, it shall be necessary for the Centres of Legal Education to deposit Rupees Two Lakh in shape of guarantee to fulfil all the norms of the Bar Council of India. The same shall be liable to be forfeited if norms are not complied with and same shall carry no interest.”***

The approval of affiliation now granted by the Bar Council of India is subject to the payment of guarantee amount as mentioned in the above rule.

College authorities are also required to apply to the Bar Council of India for further extension of approval of affiliation six months in advance before expiry of the period of approval of affiliation granted by the Bar Council of India i.e. on or before 31<sup>st</sup> December, 2013 failing which a late fee will be charged..
