#### 1. Preamble

This Memorandum of Understanding (MoU) is executed between Mewar University, Gangrar, Chittorgarh, Rajasthan, and Madhav College, Rajwade Bhavan, Gwalior, Madhya Pradesh, with the intention to promote academic cooperation, faculty development, and student enrichment.

#### 2. Purpose

The purpose of this MoU is to establish a collaborative Faculty and Student Exchange Programme for a period of three (3) years to enhance academic quality, cultural exposure, research activities, and institutional growth.

#### 3. Areas of Collaboration

Both institutions agree to collaborate in the following domains:

- a) Faculty exchange for academic teaching, workshops, and research.
- b) Student exchange for academic exposure, internship, training, and skill development.
- c) Joint seminars, conferences, FDPs, and academic events.
- d) Sharing of study materials, research resources, and infrastructure (subject to policy).
- e) Joint research publications and academic contributions.

### 4. Duration of the MoU

This MoU shall remain valid for three (3) years from the date of signing by both parties. It may be extended further through mutual consent.

### 5. Responsibilities of Both Institutions

Mewar University and Madhav College shall:

- a) Identify faculty and students for exchange.
- b) Provide necessary academic support and guidelines.
- e) Ensure safe and conducive campus environment.
- d) Facilitate required certificates, permissions, and evaluation processes.
- e) Share progress reports of exchange activities annually.

# 6. Financial Arrangements

All financial matters including travel, accommodation, and other expenses will be mutually decided and borne by the concerned institution/individual, unless specifically agreed otherwise.

### 7. Implementation Committee

Both institutions shall form a Joint Coordination Committee to monitor and review the activities under this MoU.

#### 8. Termination Clause

Either party may terminate the MoU by giving a written notice of 30 days. However, ongoing activities will be allowed to complete smoothly.
