- The Training lasts for 20 Full days.
- Accommodation will be provided for both boys & girls separately in our own hostels along with meals (Breakfast, Lunch, Tea in the aftn and Dinner)
- The cost per student is 18000/- which includes Industrial visit, Lab training, Accommodation and the transportation cost while going to the industry.
- Out of 20 days, 2 days will be taken to the industrial visit in our own transportation.
- And the rest of the days will be instrumentation training in the Lab. This includes the handling of instruments by the students.
- We will divide the students into groups and the max pax per group will be 6 members only. By doing this there will be no clumsy situation at the instrument and the understanding will be good if there is less number.
- We will teach them the theoretical part along with the practicals. First, we will explain everything to the students about the instrument then we will ask them to run and troubleshoot the instrument. By doing this, it will be very helpful at the time of industry work.
- Also, we will take the demo from the students for self-assessment.
- At the end of the training, the Student will get the Industrial Training certificate as per PCI guidelines.

The training will be held as per the COVID-19 regulations. Utmost care will be taken during the training period.


